


## Kia ora Stuart

The average used in my memo simply refers to the 50<sup>th</sup> percentile for the period. References to "above and below average" simply mean above or below this value and have been represented as a percentage of the average in the table.

The NRC Climate Hydrology Report refers to "normal" as being the 40<sup>th</sup> to 60<sup>th</sup> percentile. This is meant to be a broad indication of the situation, not a detailed statistical analysis. Terming this small section of the data "normal" can be misleading as it only represents 20% of the data. The plots in the memo have an envelope (pale green) that represents the middle 50% of values (i.e. 25<sup>th</sup> to 75<sup>th</sup> percentile), half of the data falls within this range.

I have provided two plots below to demonstrate the limitations of the 40th to 60th percentile range used as "normal" in the Beca report (7 March, 2024). The first plot is a duplicate of the 2022-year plot from my memo (with a 25<sup>th</sup> to 75<sup>th</sup> percentile envelope, pale green), the second plot has an envelope (pale green) covering the 40th to 60th percentile or "normal" range in the NRC Climate Hydrology Report.





I hope this answers the question.
